## Please give a description of what you want this grant for - (please limit your answer to 500 words or less)

The grant will be used to undertake many jobs at the club that will allow the safe return to its members and to increase the numbers of new people to the club. After the club had been closed for 2.5 years due to the pandemic, it recently opened its doors welcoming back its members. When the club reopened it was obvious that there was major works needing done to the green and its surrounding area. The green itself was a mess as there had been no treatment over the closure period. There is also damage to the trees and a tree surgeon will be needed to do the specialised work. With no income being received and still having the same expenses the club will find it difficult to purchase all the required equipment to ensure an ongoing safe return for its members. The grant will also be used to ensure that the club have all the equipment / products required to have a safe return to the club for all its members and visitors.

The club will ensure that its members and visitors have confidence in returning to the club on a regular basis by providing hand sanitisers, hand washing / drying facilities etc.

The club also want to make sure that the facilities are welcoming and attractive for all people to visit. The introduction of prominent signage on approach to the club and in the vicinity of the club is important to show the community where the club is. The area around the green is desperately needing cleared up and maintained on a regular basis. At the moment it is too big of a job for members to tackle and professional help is required. The areas outside the green also requires maintenance work and although Dundee City Council cut the grass, this is not on a regular basis

or to a standard that members are happy with. Members are willing to undertake some of these maintenance tasks themselves but as described earlier the task is too big for the current membership. Several of our members have assisted in the past to do regular maintenance, but they are frustrated that they cannot now do the same level of work as they previously did but feel if the work was completed then they can manage it going forward.

1. Improving Public and Green Spaces

- Take action to improve the quality and usage of public and green spaces
- 2. Promoting wellbeing and supporting recovery Reducing social isolation, promote wellbeing
- 3. Building Community Resilience Increase the amount of social, learning and physical activities available in the East End

#### How many people will benefit from this project?

40+

Will any specific groups benefit from this project? (male, female, age range or protected characteristic)

All characteristics will benefit. No one is excluded from membership from the club and there has been an increase for example, of members with a disability and a younger age group than previous years. In future, the club will continue with a focus on opportunities for children and young people. We have a current membership of 32 bowlers, but we feel once all the work is carried out that the club will become more attractive to more people. Specific work will also be planned to attract new members for the new season. We will work with the local community officers, schools, care homes and businesses in the area to attract new people to the social and physical benefits of the sport. Therefore, an increase to over 40 members we feel is achievable.

There is a clear need in the East End for low cost, physical activity that will benefit an individual's physical and mental health. The current crisis and recent pandemic have made many people isolated and the need to get out and socialise is much needed. Over the last 2.5 years people have forgotten what normal is, however, it is evident that they need to get back to doing the activities they once did. Also, it has become even more evident that organisations such as Balerno Bowling Club play an important part in encouraging people to try new activities and to feel that they belong and have a role in their community. All the current members have stated how delighted they are that the club has reopened its doors and see it as a source of companionship.

The Club makes people feel they belong and have a purpose and a role along with their peers in making the club successful. This clearly will benefit all individual's mental health. The club also feels that it has a role to play in the community eg. youth work, intergenerational work, links with schools and care homes. These are all areas that can be improved and supported by the sport of bowls and the experiences of the current membership.

#### What local consultation has taken place regarding this application?

Questionnaire was sent out asking if people were wanting to return to the club. Many responses were received and all were positive. There was a small number of responses not returned but after reviewing this we now know that people have moved house, passed away or health no longer allows them to play. Further discussions have been held with the club's current members who have stated many times that they feel the club is needed and provides a benefit to the local community. These include creating closer links with the community, community centre and its management group along with the local schools.

Further discussions have been held with the Local Community Empowerment Team who have helped advise on the potential links and areas of work with the local community.

#### What evidence do you hold that the local community supports this application? (For example, was it proposed by members of a particular group? Does it directly address need identified by community members?)

Balerno Bowling Club members, who are all part of the local community and regularly use the services of Douglas Community Centre and its staff, wish to extend the benefit of bowling to more people within the community. The Local Community Plan has been consulted on by various local people and as indicated earlier, this application meets some of the identified priorities within the plan. Early discussions have been held with Janet brougham Care Home who have expressed an interest in utilising the club and this will be progressed for the new season.

Early discussions have also been held with Active School Coordinators with a hope to link with the local schools. The Coordinators see a benefit to this.

The club is situated in Douglas and is in easy reach for all members of the community to access without the requirement for transport. The current fee structure is very low, and it is hoped that this would be affordable for a wide range of people to manage. The club will also, in the future, be revisiting the fee structure to ensure the fees can stay low while making the club sustainable. The club has many sets of bowls that can be used for new players who cannot afford to pay for the expense of a bowls set. Further pockets of funding will sourced to ensure those people that are in the most deprived areas can still access the club without the concern of affordability.
